This puppy is guaranteed to the original named original buyer owner stated on page 1 of this contract. Against any debilitating or life threatening hereditary/ congenital diseases including



hip dysplasia (moderate or severe for limited registration). Should the puppy develop a scientific proven genetic disease that is confirmed by 2 different licensed veterinarians during the first 26 months of age the breeder will replace puppy with another puppy of equal value (determined by breeder when available) or buyer may pay the difference of a more valuable puppy (determined by breeder). If puppy is bred guarantee is null and void. Breeder does not guarantee against giardia and or coccidia as these are common protozoan's that are often dormant in puppies and are brought on by stress such as shipping and/ or a new home. These conditions as well as worms are easily treated and the responsibility of the buyer. Breeder does not guarantee bite. There are many factors such as retained baby teeth that can change the bite. The buyer agrees to limit the amount of exposure puppy has to public areas until all vaccinations have been given (16-18 weeks of age).

The Breeder warrants that the puppy is in good health and free from communicable and non-communicable diseases until leaving Breeder's property. The breeder shall provide the buyer with the puppy's inoculation records upon delivery. The breeder offers a 72 hour well puppy health guarantee. The buyer is required to take puppy to a licensed veterinarian for a well puppy check-up/ exam within 72 hours of possession. If the puppy is diagnosed with any untreatable illness a replacement puppy of the same value will be given with the return of the first puppy (including all registration documentation, inoculation records) at the buyers expense. Buyer to provide the consulted licensed veterinarian contact information (including name of vet practice, address, veterinarian's name, Veterinarian's name and phone number including documentation records) to discuss the diagnosis and situation in full. No veterinary or shipping costs will be reimbursed by breeder. This agreement is made and entered into the state of Missouri and shall be informed and interpreted under the laws of the state of the state.

This guarantee is void if the dog/ puppy is found to be overweight and/or fed a poor-quality diet. The buyer agrees to hold off on any strenuous repetitive exercise (agility, long walks, hiking, etc.) until dog has reached at least 1 year of age. Strenuous repetitive exercise is hard on hips, joints and will render this health guarantee null and void. Not included in this health guarantee are health issues that may be caused by environmental factors such as allergies, autoimmune disorders, trauma, abuse and failure to maintain general health of the dog. If the dog represented in this contract dies, it is the buyer's responsibility to notify breeder immediately as a necropsy and or biopsy may be needed to determine the cause of death.

The buyer agrees to provide this puppy with proper veterinarian care, diet, housing, socialization, and grooming for his/her entire life. the puppy will have age-appropriate vaccinations. Please do not over vaccinate!!!! If the puppy is given vaccinations before the date



stated on provided records, the guarantee will be null and void. Over vaccinating is very dangerous and could result in illness and/or death!!!! **DO NOT OVER VACCINATE!!!!** The puppy should be groomed every 6 to 8 weeks. The buyer agrees that if any time in this puppy's life they are unable to keep him/her they will return him/her to breeder. Under no circumstances shall this puppy be placed into a shelter, pet store, rescue, or foster care. The breeder will take puppy back or help find him/her a new home at any time during his/her life.

The buyer shall not resell, give away or otherwise relinquish care of the dog without the breeder's full written consent. If the dog is sold, given away or in any other way no longer in the buyer's possession or bred, the buyer will pay a minimum fee of 3 times the original purchase price of the dog at the breeder's discretion.

The breeder agrees to be available for help throughout the entire life of the dog. The breeder maintains a continuing interest and pride in this dog and its accomplishments. Any phone calls, letters, photos, updates, etc. are always welcomed and greatly appreciated.

Regarding full registration:

Buyer agrees the registered name will begin with Jazzy's.

Buyer agrees to show to the tile of UKC Grand Champion and/or AKC Champion before breeding. Buyer will not breed until females are 2 years old and males 18 months and appropriate health testing has been completed to OFA CHIC standards or higher for the specific poodle purchased. Buyer agrees to breed only to AKC registered poodles no merles, no doodles, and must be the same breed (example Standard Poodle to Standard Poodle). If buyer deviates from this agreement during breeding legal ramifications will be sought, and the buyer will pay the breeder \$10,000 plus any and all expenses including but not limited to attorney fees, and compensation for damage to breeder's reputation. This agreement is for the entire life of the dog. The buyer will also forfeit ownership and return the poodle back to the breeder at buyer's expense. This agreement is made and entered into the state of Missouri and shall be informed and interpreted under the laws of the state.

This document is a legal binding document. Any court cost and attorney fees necessary to enforce this contract shall be paid by buyer, in the state of Missouri, and the laws of Missouri, in the County of Butler, United States of America will govern the interpretation of this contract. This guarantee applies to the original buyer only and is non-transferable

Breeder does not guarantee size or color. We can only guess expected weight, height, and color.
